The competition is open to persons who meet the conditions set out in the Act of 20 July 2018. Law on Higher Education and Science (Journal of Laws 2018, item 1668 as amended) and the Statute of the University of Wrocław.

# Requirements

The conditions that the candidate should meet:

- Knowledge of the Polish language to a degree enabling conducting classes in this language.
- Knowledge of the English language to the extent that allows conducting classes in this language.
- The candidate must hold a PhD degree or habilitation in the field of art history (or arts studies); PhD degree or habilitation in the field of culture and religion studies (or culture studies), if the candidate also holds at least BA or MA in the field of art history (or art studies).
- Publication in the last five years of a scientific monograph or at least two scientific articles in journals assigned to the discipline of Art Sciences and on the ministerial list of scoring journals.
- In the last five years, obtaining, conducting or participating in a national grant of one of the indicated institutions (Ministry of Science and Higher Education, Ministry of Culture and National Heri-

tage, The National Centre for Research and Development, Foundation for Polish Science) or obtaining equivalent financial support for research from national or foreign institutions or submitting at least one application in grant competitions that was assessed positively (in the case of known scores reaching a minimum of 70%) in the last stage of the assessment, but did not receive funding due to lack of funds.

- Having a special knowledge of the history of Modern art (from the end of the 18th) and Contemporary art.
- Research activity on Modern and Contemporary art documented in publications, with particular emphasis on the history of architecture and / or contemporary art.
- Documented teaching experience in higher education (the selection board reserves the right to ask for an open lecture from candidates standing for the competition).

#### Responsibilities

- In the research area: conducting research at a high academic level, including publishing in journals and publishing houses, which provides a high score for an evaluation of the discipline of arts studies; applying and obtaining external funds for research.
- In the teaching area: teaching classes in the usual teaching load.
- In the organizational area: participating (as it will be required) in the organizational work of the Institute (councils, commissions, and working groups).

The application for the competition should include

- Personal questionnaire of the applicant for employment (download Personal questionnaire).
- · Curriculum vitae.
- A photocopy of the diploma certifying the PH.D. or post-Ph.D. academic degree.
- A declaration that, in case of winning the competition, the University of Wrocław will be applicant's main place of work (download Statement on place of work).
- A declaration as to the discipline in which the candidate will carry out research and, in the case of those carrying out research in more than one discipline: the percentage of their involvement in each of these disciplines (download Declaration of scientific discipline).
- The self-report containing the characteristics of the scientific and didactic experiences to date and other achievements in the field of organization and popularization of science.
- List of scientific publications in the period no longer than the last 10 years.
- Electronic versions of two of the most important publications which the applicant considers to be representative of his/her scientific output, or an explanation of their absence.
- Application for employment addressed to JM Rector including a description of applicant's scientific interests.

The President of the Selection Board reserves the right to ask applicants to submit copies of any scientific publications or other documents required to assess their candidature.

CV should include the following note: I consent, within the meaning of Articles 4 and 7 of RODO, i.e. Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EU L of 4.05.2016, pp. 1-88), to the processing of my personal data by the University of Wroclaw, pl. Information clause for persons participating in the recruitment process
