We are looking for contributions that highlight lesser-known, often still undocumented women who have contributed to the preservation and conservation of both tangible and intangible heritage. The goal is to showcase their achievements and contributions to the development of monument conservation and to ensure that their legacies are not forgotten.

By publishing articles on the theme of herstory, we aim to draw attention to the invaluable (and often underappreciated) role of women in the preservation of heritage and their contributions to conservation efforts. We particularly encourage research on individuals whose lives and work have not yet been sufficiently documented in academic literature. We would like to feature determined, passionate women whose knowledge and skills have contributed to the conservation of heritage and the restoration of monuments to their former glory, the results of which can often still be admired today. We hope that these articles will not only enrich the understanding of the history of conservation but also serve as an inspiration for future generations of conservators and art historians.

You are warmly invited to submit scholarly articles that fit the profile of Ochrona Zabytków.

We are particularly interested in articles that are based on in-depth research which presents new information and which provides a deeper understanding of the role of women in the important field of heritage conservation.
